

Effective Date: When beginning a quote be sure to use the actual effective date and not the date that you are entering the risk into COL. This helps ensure the correct rate is applied.

Quote Letter: Once the risk is entered and fully quoted in COL, create the quote letter. After filling in the information on the quote page; click the **"Save"** button, and then the **"Print/View Quote Letter"**. This will produce a pdf of the quote that can be saved or sent directly to the agent.

Lock the Quote: It is very important to now "Lock" the quote which locks the quoted rate, terms and coverages. In the case of a product change between quoting and binding, this will ensure the rates, terms and coverages remain as quoted.

Unlock Quote: Once the quote is locked, the "Bind Quote" and "Unlock Quote" buttons will appear. The "Unlock Quote" button allows changes to be made to the quote. When using the "Unlock Quote" feature, double check rates and terms as changes may occur when unlocked. To make simple changes such as the date on the quote, do not unlock the quote, there is an option to change the effective date on the binding page (see next step)

Bind Quote: On the "Bind Quote" screen, the effective date can be updated if necessary. Double check the premium on the left side of the screen and then click the blue button on the bottom labeled "Bind with COL – Assigned Policy Number (Recommended)".

Create Bind Letter: After clicking the bind button, the policy number will be displayed. Now click the "Create Bind Letter".
